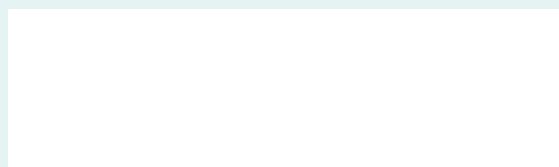


HBL Islamic Basic Banking Account is specially designed to cater the needs of individuals who need a simple Shariah compliant bank account with low transactional requirements.
