 Requirements to open an account: To open the account you will need to satisfy some identification requirements as per regulatory instructions and bank's internal policies. These may include providing documents and information to verify your identity. Such information may be required on a periodic basis. Please ask us for more details by visiting any of our branch. Cheque Bounce: Dishonoring of cheques is a criminal offence under Section 489-F of the Pakistan Penal Code of 1860 and Section 20 of the Financial Institutions (Recoveries of Finance) Ordinance of 2001; and is subject to a criminal trial in Pakistan. Accordingly, you should be writing cheques with utmost prudence.
